

Large-Scale Managers Workshop Scholarship Application

Application Deadline: July 16, 2010

Scholarship Overview

The Association of Professional Community Managers (APCM) Large-Scale Managers Committee has established a scholarship fund to provide financial support for large-scale managers to attend the annual Workshop. Scholarship winners will receive a maximum of \$1,000 to cover the lodging expenses at the Workshop hotel and registration for the Workshop. Two scholarships are available for the 2010 Workshop. **The 2010 Workshop will be held in Reston, Virginia from September 22-26, 2010.**

The Large-Scale Managers Workshop Scholarship Task Force members are the judges for the scholarship. The Task Force includes the immediate past recipients of the scholarship(s), the immediate past Workshop host, the current Workshop host, and at least one other member of the APCM Large-Scale Managers Committee.

Applicant/Scholarship Criteria

Scholarship Requirements

- The scholarship must be used for the 2010 APCM Large-Scale Managers Workshop.
- Funds may be used for registration, travel, or lodging directly related to the APCM Large-Scale Workshop.
- Scholarship winner must attend the full Workshop.
- Scholarship applicant must be a CAI manager member in good standing.
- Scholarship applicants must be or must have been previously employed as a general manager or executive director level large-scale community manager. (*Large-scale community is defined as a community with a minimum of 1,200 units or minimum of 1,000 acres and a minimum of \$1.5 million operating budget.*)
- Only one scholarship per association per year will be awarded.
- Only one scholarship per individual (lifetime) will be awarded.
- Unemployed applicants will receive priority consideration.
- Timeline:
 - Deadline to submit application is July 16, 2010
 - Winners are notified by August 6, 2010
