<u>Best Manuscript Award.</u> The CAI Law Seminar presented by the College of Community Association Lawyers is the premier continuing legal education conference exploring trends and practices in community association law. In 2023, more than 20 sessions were offered to community association lawyers from around the United States. Each seminar is required to have a manuscript accompanying the presentation.

In 2014 the CAI College of Community Association Lawyers established the Best Manuscript Award. A committee of dedicated attorneys scrutinizes every manuscript submitted and selects one that best reflects the dedication of the presenters and the quality of education provided at the Law Seminar. The Best Manuscripts serve as benchmarks for Law Seminars to come. This year Lynn Krupnik, Esq., CCAL, Krupnik & Speas, PLLC, Anthony Rafel, Esq., CCAL, Rafel Law Group, and Kim O'Halloran-Perez, Esq., CCAL, Rees Broome, graciously served as CCAL's Best Manuscript Committee – reviewing over twenty manuscripts. <u>CCAL Fellow Application Requirement Updates and June 30 Deadline</u>. After great thought and consideration, the CCAL Membership Committee and Board of Governors has approved the following changes to the current CCAL Application:

CAI's Community Association Law Seminar attendance requirement has now been changed to
"attendance at two (2) Law Seminars in the prior 10 years, and one (1) of which has been in the last 5
years."

 A new line item in the CCAL application scoring matrix has been added. If you have attended six (6) or more Law Seminars in the last 10 years, this will be counted .5-1 point towards industry involvement.

The next CCAL membership application deadline is June 30. Applicants must have completed a minimum of eight years of legal practice with a demonstrated focus in community association law, five of which must immediately precede the date of application. They also must be a member of CAI and have attended two CAI Law Seminars in the last ten years, with one in the last five years, and demonstrated significant leadership and involvement in the provision of legal services to community associations through the attainment of 12 out of a possible 15 points in the evaluated application categories.

<u>CCAL Mentors.</u> I encourage everyone to volunteer to participate in the CCAL Mentor program. The program helps lawyers new to our industry develop skills unique to community association law, provides networking opportunities, and guides lawyers toward completing their application to become a CCAL fellow.
