<u>CCAL Fellow Applications Due June 30</u>. The CCAL membership applications deadline is June 30. Applicants are required to have completed a minimum of eight years of legal practice with a demonstrated focus in community association law, five of which must immediately precede the date of application. They also must be a member of CAI and have attended at least three Law Seminars within the past 10 years, with one in the last three years, and demonstrated significant leadership and involvement in the provision of legal services to community associations through the attainment of 12 out of a possible 15 points in the evaluated application categories.

<u>CCAL Mentors.</u> I encourage everyone to volunteer to participate in the CCAL mentor program. The program helps lawyers new to our industry develop skills unique to the practice of community association law, provides networking opportunities, and guides lawyers toward completing their application to become a CCAL fellow.
