Dear Fellows and Community Association Law Counsel,

Judges throughout the United States at times reduce our requested attorney fees for various reasons, including something like they are above market rate. Of course, the market is never well-defined. I intend to help. The market, from my viewpoint, is another attorney who devotes a significant amount of her or his practice to community association law.

In truth, this is a very specialized field, far more specialized than, for example, the mediators that many judges require or "suggest" we use to settle cases at \$400-\$500 per hour. I consider community association attorneys similar to attorneys who specialize in family law, tax, mergers and acquisitions, environmental or real estate law. In your state, what are the top lawyers in those fields charging? There is no reason your rate should be less for litigation work than it is for non-litigation work. Don't undersell yourself. We are a specialized field and well worth every penny we charge.
