(20pts)</p> <p>In 2023, The Central VA Chapter launched a strategic initiative to develop a formalized business plan focused on sustaining growth and enhancing member value. This initiative continued into 2024 and was further expanded and enhanced, with the Board of Directors reaffirming its commitment to driving meaningful benefits for Community Association Managers, Business Partners, and Volunteer Leaders—three core membership categories that define the strength of our organization.</p> <p>Our approach to Driving Member Value recognizes that each membership group has unique needs, yet many opportunities overlap.</p> <ul style="list-style-type: none">• For Managers, we expanded educational programming and professional development, creating new avenues for engagement and career growth.• For Business Partners, we introduced refined pricing strategies within sponsorship categories, ensuring greater return on investment and increased opportunities to interact directly with managers and volunteer leaders.• For Volunteer Leaders, we developed enhanced networking and educational opportunities, including a Strategic Planning Workshop, to cultivate leadership skills and strengthen their impact within their associations. We continue to utilize the LAC in its fullest capacity to ensure proper advocacy in our government and legislature. <p>Beyond these initiatives, our leadership extended outside of our own chapter's borders. In a true demonstration of collaboration and commitment to the industry, the Chapter Executive Director (CED), with full support and approval from the Board, provided operational assistance to a neighboring chapter that was facing leadership challenges. This proactive support ensured continuity for a partner chapter during a difficult transition, reinforcing CAI's mission of collective strength and professional excellence.</p>

(20pts)</p> <p>Alignment with CAI's Mission and Chapter Vision:</p> <p>By fostering education, advocacy, and engagement across our three membership categories, our chapter is fulfilling CAI's core mission: empowering community association professionals and leaders to build stronger, well-governed, and effectively managed communities. Our leadership efforts with a neighboring chapter ensured that their operations continued seamlessly while they searched for a new Chapter Executive Director. Additionally, our commitment to corporate social responsibility was demonstrated through partnerships with local non-profits, where we led critical home improvement efforts. This initiative not only increased the chapter's visibility but also reinforced our dedication to community outreach and responsible citizenship—a key pillar of CAI's overarching mission.</p>

(Growth of membership, financially, public awareness, membership value, better chapter/member relationship, chapter operations, etc.) (20 pts)</p> <p>Our strategic focus in our enhanced Business Plan on Driving Member Value has yielded measurable success:</p> <ul style="list-style-type: none">• 32.8% membership growth over two years, propelling the Chapter from a medium-sized to a large Chapter.• Increased member retention and engagement across all categories, strengthening relationships and fostering long-term involvement.• Positive budget impacts due to higher retention, sponsorship participation, and expanded educational offerings.• Enhanced volunteer recruitment and leadership development, ensuring a pipeline of dedicated professionals to sustain the chapter's long-term success.• Strengthened community reputation through outreach initiatives, reinforcing CAI's role as a leader in community association advocacy and education.
