Managers and business partners participate at much higher levels because their member dues, training fees, sponsorships and exhibitor fees are usually paid for by industry companies. CAVLs must pay out-of-pocket to participate, even though they ultimately spend the association money that actually fuels the industry and CAI. We need a viable funding strategy through education, best practices or even regulation that encourages reasonable use of association funds to train and support CAVL full participation in CAI. One small symbolic change should be expanding the Homeowner Leader Council from 6 to 12 members like the manager and business partner councils.
