Keeps you informed and involved. The Nevada Legislative Action Committee
(NVLAC) organizes "grassroots" advocacy campaigns — letters, e-mails, phone, and
social media communications regarding important issues related to community associations.

Strengthens key relationships with lawmakers. By educating lawmakers, legislative and executive staff, and other organizations, as well as testifying, the committee helps advance issues facing community associations and influence the outcome of legislation.

Advocacy Successes. During the 2025 state legislative session. CAI NVLAC
 worked tirelessly to navigate through many bills, and we are proud of the results of the legislative season.

**SB 121-** NV LAC opposed this bill when it was initially proposed, as it imposed unreasonable statewide mandates on associations. While NV LAC was able to get some amendments passed to improve the bill, ultimately what passed through the legislature was still too burdensome for Nevada's community associations. SB 121 impacted many aspects of community association living, including management agreements, parking commercial vehicles, landscaping, and removal of oil stains.

Status: Successfully VETOED by Governor.

**AB 185**- NV LAC opposed this bill when it was initially proposed, as it contained provisions conflicting with the recommendations found in CAI's <u>Residential Childcare</u> <u>Facility Public Policy</u>. NV LAC successfully worked with legislators to amend the bill to be more in line with CAI's public policy recommendations and ultimately took a neutral stance on the bill.

Status: VETOED by Governor.
