

Construction Defect Warranty State Statutes

Updated November 2025

Every state plus DC has statutory language governing construction defect warranty claims. However, not all states have comprehensive statutory language which communities can turn to in order to determine appropriate next steps in a construction defect claim. Associations and homeowners should continue to seek legal counsel as appropriate when faced with a construction defect issue.

Key Data Points:

- 13 States (CO, IL, ME, MD, MI, MO, NE, NH, OH, OR, RI, UT, WA) plus DC have statutory language specifically covering condominium warranties. Washington State's statute only covers condominiums constructed after July 27, 2025.
- 22 States (IA, ID, IN, KS, KY, LA, MN, MT, NC, ND, NM, NV, OK, PA, SC, SD, TN, TX, VT) have statutory language that explicitly covers all dwelling units.
- 4 States (GA, MS, NJ, VA) have statutory language that explicitly only covers single-family units. Virginia's language also covers townhome units.
- New York's statute is the only one which explicitly applies to units based on height (5 stories or less).
- Maryland has separate statutes covering units in HOAs and condominium associations.
- 3 States (CA, TX, VA) explicitly require a disclosure form or statement as part of real estate transactions.
