

## **National Condominium Data and Statistics**

In the American Housing Survey, there are an estimated 7,415,000 condo units listed nationally, out of a stated estimated housing stock of 124,135,000 units in total. The American Community Survey divides housing stock based on proximity to a Central or Non-Central City, as well as Micropolitan and Non-Micropolitan areas. Please be aware that data from the American Housing Survey excludes certain states and metropolitan areas. Full Census Bureau data on the number of housing units nationally is available in this document.

Note: Please note that due to data sources, different methodologies, and data limitations from the American Housing Survey, the information in this report does not exactly match published Foundation for Community Association Research (FCAR) data. FCAR's data is more comprehensive using many data sources to estimate community association data and statistics. ## **American Housing Survey Data:**

• An estimated 4,122,000 condo units, or 55.59% of total condo units surveyed, were built before 1990. 2,235,000 of these units were listed as owner-occupied, which is 52.52% of surveyed owner-occupied condo units nationally.
